Representative Matters

- Represented a nationwide equipment distributor in multi-jurisdictional successor-liability litigations involving alleged exposure exceeding \$150 million. The matters included separate actions filed in New Jersey and California federal courts and New Jersey Superior Court, as well as representation of a company principal in a related Chapter 11 bankruptcy proceeding in New Jersey.
- Advised a medical practice in a Chapter 11 bankruptcy proceeding involving competing claims from a private equity sponsor, an acquisition lender, and the practice's physician owners. The matter addressed disputes arising from the dissolution of the practice, restrictive covenant issues, and claims exceeding \$35 million. The firm guided the parties to a global settlement and confirmation of a Chapter 11 plan of liquidation, resolving all claims.

The debtor owns and manages a commercial condominium consisting of office and warehouse space.
